Types of Legacies

If you would like to remember The Douai Foundation in your Will, there are three main types of gift you can make:

- **Residuary Gift** - is the gift of all (or part) of the value of your estate after debts, liabilities and other legacies have been paid
- **Pecuniary Gift** - is the gift of a particular sum of money.
- **Specific** - is the gift of a specified item that could be for example; a property, artwork or jewellery.

Suggested wording for a gift in your Will

If you would like to leave The Douai Foundation a gift in your Will the following wording may assist you when meeting your solicitor:
